## ONSITE SEPTIC INSPECTION INCENTIVE PROGRAM OVERVIEW

Island County property owners who own a private residence that utilizes a septic system are eligible to apply for an inspection incentive to help subsidize the cost of a routine full septic system inspection performed by a participating licensed septic maintenance service provider.

### Incentive Options Available

#### GENERAL INSPECTION INCENTIVE

**\$150 off**  
for property  
owners **not**

#### LOW-INCOME INSPECTION INCENTIVE

**\$350 off**  
for property

choosing to

## OVERVIEW OF THE INCENTIVE

The inspection incentive subsidizes the cost of a routine full system inspection up to the maximum incentive amount. If a full system inspection as well as additional work is performed at that time, then up to the maximum award amount can be applied towards the customer's total bill.



## ELIGIBILITY



To be eligible you must:

- ✓ Own a property with a private residence in Island County with a septic system. *Commercial sites do not qualify.*
- ✓ Have not received an incentive from this program in the past three years.
- ✓ Submit the application and wait for your inspection incentive certificate.
- ✓ Have a full system inspection performed by a participating Licensed Maintenance Service Provider. Provide them with your incentive certificate at time of inspection. *Property sale inspections do not qualify.*
